***You should apply this year!**

Attached to this Dragonflyer (27#1) newsletter is a fillable form that members can use to apply for the OOS Small Grant for 2017-2018. A paper-copy of the application form can be found at the end of this newsletter.

Below is re-printed / updated from the dragonflyer Volume 21#2, 2011

This is the call for proposals that is open to current OOS members in good standing (i.e. paid for the year proposal is submitted (2017) & potentially funded). The recipient, or recipients, of the small grant (if any) will be expected to present their findings, or project overview and results, to that point at the annual OOS meeting the following year. (i.e. projects receiving a small grant in 2017 must present at the 2018 annual meeting).

Small grant proposals up to a maximum of \$500.00 will be evaluated and considered. The OOS officers serving at the time of the proposal submission will form the committee to evaluate, accept and potentially fund the proposal (or proposals). Duration of the small grants program will be limited by the amount in treasury that exceeds anticipated operating funds and will be suspended upon depletion of the OOS funds available. Application form and details, deadlines and evaluation procedures are in the attached application form. If you have trouble with this document please contact newsletter editor Steve Chordas III (stevechordas@sbcglobal.net) or contact Steve by phone at 614-421-7159 and we will get a form to you. Also see the motion for the small grants in the meeting minutes on page 4 of the 2011 Dragonflyer (Volume 21 Number 2, 2011).

NEW TO OHIO: *ENALLAGMA ANNA*, RIVER BLUET - WOW!

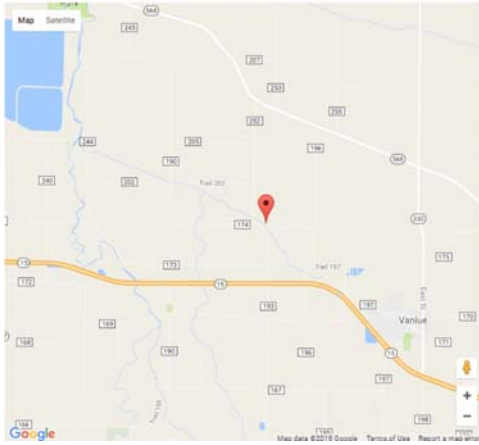

Enallagma anna in Hancock County, Ohio? Yes indeed.

This year (2016) was the first year of my 5-year odonate survey for the Hancock Parks District (HPD) and the Hancock County Naturalists (HCN). Over the course of this year, I've found 13 species that are new for the county, based on the most recent OOS database. Additionally, I've confirmed all but two species that had been previously recorded for the state, including *Dromogomphus spoilatus* (Flag-tailed Spinyleg) that hasn't been recorded in the county since 1960!

Bright's Ditch is a small channeled ditch that runs through Amanda and Biglick townships. This is fed by a spring near Vanlue and meanders to the Blanchard River near the Findlay Upground Reservoirs. Mostly surrounded by agricultural fields, this ditch has been surprisingly diverse from a biological standpoint. To date, I've recorded 24 species of odonates along the length of this drainage system.

On a whim, I looked from the road and saw an unusual bluet, so I snapped several pictures and headed home. (After several hours kayaking around Van Buren Lake trying to get pictures of Cyrano Darners on territory, I admittedly was a bit worn out) Two days later, I finally got around to looking at my pictures for that day and realized this one damsel was something very different. Based on OOS data, *Enallagma carunculatum* (Tule bluet) was on my list of probable finds in the county, but this

seemed different yet. I emailed a handful of far more experienced biologists than myself and they all said the same thing. "Go collect a specimen!"



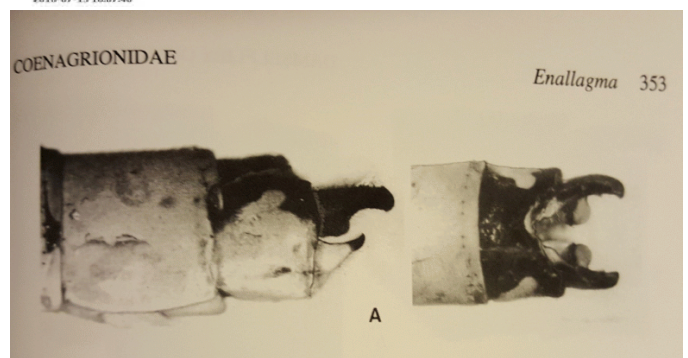

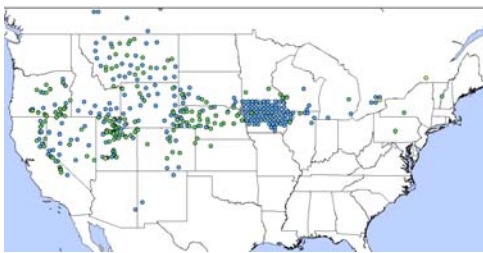

After collecting an individual, I took highly magnified images of the male cerci (images below), and compared them to the images in Westfall & May (1996) (Page 353: provided below my images).

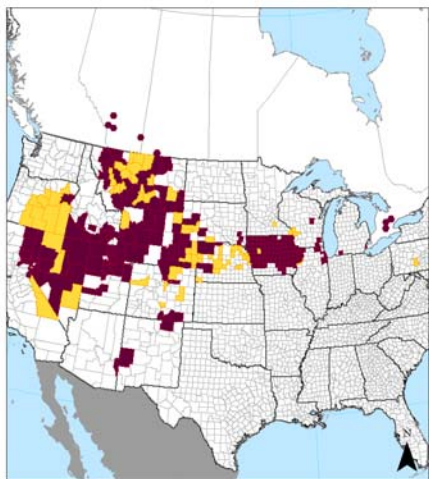

OHIO ODONATA SOCIETY ANNUAL MEETING MINUTES : 2016 Saturday 30-July-2016 : 21 attendees

Location: Meeting held at Marietta College, Marietta Ohio.

Meeting accommodations organized by Dave McShaffery, AM refreshments and snacks provided for attendees. Nice work Dave. A sign-in sheet was passed around to attending members. Attendees ranged from local photography and nature enthusiasts to world-known collectors and professional photographers.

Dave McShaffery gave a welcome, general introduction and opening to the meeting and events for the day plus an overview of the previous day's excursions (there were 15+ that attended the Friday outings and dinner gathering).

Business Meeting: meeting was called to order by society president Rob Liptak at ~9:30am. Society President Rob Liptak asked that all in attendance introduce themselves and where they are from or their affiliation. There were 21 in attendance.

2015 OOS Business Meeting Minutes: Minutes from the OOS annual meeting held on 18 July 2015 had appeared in the Ohio Dragon-Flier newsletter (Volume 26 #1). Rob Liptak moved the minutes be approved and accepted as published in that issue; motion 2nd by Bob Glotzhober; **Approved** unanimously from floor.

2015 OOS Treasurers Report: Treasurer Bob Restifo read the treasurers report aloud, overall stating the society was in good standing and had minimal expense in 2015. Will need a copy of the treasurers report for inclusion in the minutes before they are published in the Dragonflier. Bob Restifo moved to accept the treasurers report as read; motion 2nd by Rob Liptak; **Approved** unanimously from floor.

** (taking minutes I intended to secure a copy of the treasurers report then promptly forgot to ask for a copy, minute recorders mistake, sorry, thus, no actual \$ or numbers are reported herein) Suggested addition to the OOS membership form is to have a receipt yes/no checkbox. If not checked it will be assumed no and no receipt will be sent. Receipts are sent via mail and if they are not wanted it will save time and \$\$ to not process those.

Additional Old Business? None.

Motion from the floor to close old business and proceed to new business, **Approved** unanimously from floor.

New Business:

Short, very informal, discussion of the tradition of moving officers up one rank with the election of a new member-at-large. Along this path, discussion and ultimate nomination of Shane Myers for the member-at-large was proposed. Further, it was proposed that Bob Restifo remain at his post as Treasurer of the Society (which he agreed to but pointed out that his tenure has been long and ultimately another member will need to take over this position in the not too distant future). Bob Glotzhober moved to accept the officers as nominated / indicated in the discussion; motion 2nd by Ian Anderson; **Approved** unanimously from floor. 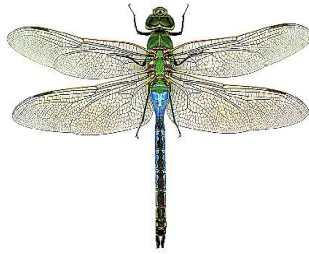
